Manufacture and sale of medical devices (digital blood pressure monitors,etc.)







# Nine months ended<br/>December 31, 2003Breakdown of Sales by Company




### Breakdown of changes in operating income




### **Breakdown of Sales Forecast**






### **Operating Income Forecast**




